## What is Army of Volunteer Advocates?

Credit union volunteers are the voice of the movement and have a very important story to tell, as well as, unique experiences and backgrounds that they can bring to bear in advocacy. Their stories are memorable, inspire action, and have the power to influence lawmaker votes and decisions.

We understand that advocacy and political involvement can be intimidating for those new to the process. The Army of Volunteer Advocates (AVA) program has been designed to make the process easier for both the seasoned advocate and the rookie. Volunteers are welcome to jump in with both feet or dedicate a small amount of time - all commitment levels are welcome and the volunteer's choice!

## What is involved with the AVA?

Army of Volunteer Advocates opportunities include: future League sponsored training, CUNA Government Affairs Conference, Jam the Unicam Conference, League Annual Meeting, visits with local, state, federal lawmakers and candidates.

- **Grassroots Action Center**: Volunteers are encouraged to respond to action alerts sent by CUNA and/or the Nebraska League.
- **Advocacy Training**: The League and CUNA are working to create advocacy training opportunities where volunteers can learn best practices in advocating for their credit union at all levels of government.
- **Local Candidate Events:** When appropriate, volunteers will receive notification of local events to connect and build relationships with lawmakers.
- Nebraska Credit Union League Political Action Committee (NCULPAC): Membership in NCULPAC and participation in NCULPAC events help ensure credit union friendly candidates are elected to office.
- Advocacy Events: CUNA Government Affairs Conference, Jam the Unicam, lawmaker and candidate visits, town hall meetings.
- **Community Groups**: Participation in local community groups and activities such as the local Chamber of Commerce, Rotary Club or other community groups serves not only the individual well, but indeed the credit union movement.
