

## Millennium Corporate Credit Union Announces Retirement of Long-Time President/CEO, Larry Eisenhauer

**Wichita, KS** (February 6, 2024) – Millennium Corporate Credit Union shared today that their long-time CEO, Larry Eisenhauer, announced his retirement effective June 30, 2024.

Mr. Eisenhauer began his credit union career in 1985 when he accepted a position with the Kansas Credit Union Association as a League Consultant. Shortly thereafter he was promoted to Account Executive for Kansas Corporate Credit Union. He held multiple positions with Kansas Corporate before being promoted to CEO in the summer of 1997, a position he has held for the last 27 years.

During his tenure, Millennium Corporate completed mergers with Treasure State Corporate Credit Union (2012), and Missouri Corporate Credit Union (2015); invested in three credit union service organizations – Primary Financial Company – SimpliCD (2003), CU Business Group (2006), and CU Investment Solutions (2011); and the board returned all extinguished capital to members from the financial crisis. In addition, the AIM service (1992) – asset/liability management services for credit unions, and CorporateCash (1999), a currency and coin vaulting and delivery service, were developed.

Larry's career highlight has been working with the membership, Board, Committees, and coworkers to provide an environment that would ensure Millennium Corporate members could work cooperatively, with a wholesale financial provider they own, controlled by the membership, to meet their financial needs, independently of their banking sector competitors.

In the spirit of cooperation, Larry has served in many industry volunteer positions during his career including the Boards of CU Investment Solutions, LLC, CU Business Group, U.S. Central Credit Union, and various working groups with the Association of Corporate Credit Unions.

"It has been an honor and a privilege to work alongside Larry Eisenhauer, a true credit union champion, as we worked to strengthen and support the credit union industry. Speaking for all the board members, volunteers, credit union and corporate staff, we will miss his leadership and moreover, his daily companionship, and we wish him the best as he embarks on his next adventure," says Tom Kjar, Millennium Corporate Board Chair and Creighton Federal Credit Union President/CEO.

"Being part of the credit union family has been more than a career for me – it's been a way of life. The credit union philosophy of people helping people has guided my path, and I am proud to have played a role in advancing the goals and values we hold dear," shares Larry Eisenhauer. "My journey has been nothing short of extraordinary and I extend my sincere appreciation to everyone who shared it with me."

The board has appointed an internal search committee to identify the next Millennium Corporate President/CEO.
